INTRODUCTION

The Tag and Label Manufacturers Institute, Inc. is a non-profit trade association representing more than 300 tag and label converters/suppliers around the world.

Dedicated to improving the environment and increasing awareness of the tag and label industry, TLMI holds technical seminars and forums throughout the year to educate its members and improve product quality and production efficiency.

TLMI develops and encourages interest in entering the tag and label industry by providing scholarships to qualified full-time college students.

TLMI offers (6) \$5,000 scholarships, annually, to qualified students for their junior and senior years.

Applications are typically submitted during the sophomore year. Scholarship selection is based on academic achievement, character, a demonstrated interest in the industry, a statement of goals, and a personal interview. The awards are designed to assist the student during the last two years of college. In addition to the scholarship, internships may be offered to applicants.

Upon graduation, information on the TLMI recipients will be forwarded to those TLMI members who have expressed interest in hiring graduates, whose major course work is appropriate for a career in the tag and label industry.

GUIDELINES

- 1** The applicant must be a sophomore or junior attending an accredited college or university on a full-time basis during their junior or senior year.
- 2** The applicant must be able to demonstrate interest in entering the tag and label industry. Major course work should include those courses which are appropriate for the tag and label manufacturing industry. Such courses might include:
 - Management
 - Sales/Marketing
 - Graphic Arts
 - Graphic Design
 - Production
- 3** The applicant must exhibit proficiency in overall academics (a minimum of 3.00 GPA). Upon the applicant's request, the college or university shall send the official transcript of grades and courses to the TLMI office.
- 4** The applicant shall possess excellent character, including work ethic, honesty and integrity. References from three people, who are not family members are required.
- 5** The applicant must provide a one page, typed, personal statement which includes:
 - Personal information including any special circumstances, interests and activities
 - Financial circumstances including financial aid received and educational budget
 - Career and/or educational goals and how they might relate to the tag and label industry
 - Employment experience
 - Reasons why the applicant should be selected for this award
 - How to contact you in order to schedule a personal interview (email, phone, fax, mail)
- 6** Relatives of TLMI board members, corporate owners, and CEO's are not eligible to apply.

SCHOLARSHIP INSTRUCTIONS

- 1** Applications are available in the financial aid offices of colleges and universities, as well as from the TLMI office or www.tlmi.com.
- 2** The application must be typed or printed neatly and the personal statement must be attached to the application.
- 3** An official college transcript is required for the work completed during your freshman and sophomore years and is to be sent by the college to the TLMI office . You must be enrolled as a full-time student for your junior and senior year. A 3.00 GPA average or above is required.
- 4** Recommendations are to be completed by three people, who are not family members. The recommendations may accompany the completed application or be sent under separate cover.
- 5** Qualified applicants will be asked to attend a personal interview, which will take place at a site mutually agreed upon by the applicant and the TLMI Scholarship Committee.
- 6** All information is kept confidential. Selections will be made by the Scholarship Committee, which is comprised of TLMI members, and their decision will be final.
- 7** Recipients will be informed by the TLMI Scholarship Committee.
- 8** The college or university financial aid office will receive the recipient's \$5,000 scholarship check in two installments; one half by August 15th and the other half by December 20th. This award shall be applied to the college expenses of tuition, room and board, or the recipient shall be reimbursed, should those college expenses be paid prior to the arrival of the award. Should the student withdraw from college, the check shall be returned by the financial aid office to the TLMI office.
- 9** The recipients shall reapply for the award in their senior year by sending the TLMI office a detailed personal statement in March of their junior year. An official transcript of grades and courses shall be sent by the college to the TLMI office. The senior award may be automatic, if the recipient maintains a GPA of at least 3.00 and continues a full-time course of study appropriate for a career in the tag and label manufacturing industry.
- 10** The applicant should keep copies of all pages of the application, support materials, personal statement, etc.
- 11** The completed application and required documents must be received by March 31st.
