After TLMI receives a completed application, \$500 check, and company brochure, your information is forwarded to our membership chair for review and temporary approval. Once chair approved, you will begin receiving all mailings and membership benefits. However, before your application is officially approved, it needs to be approved by TLMI's Board of Directors.
